# **The Law and Your Business**

#### The Law and Your Business – Arbitration Provision in Contract Tony Zebouni, Lindell, Farson & Zebouni, P.A.

The Owner contracted with Construction Company ("Contractor"). for the construction of a nearly \$2 million new residence, Mr. C owned the Contractor. and executed the subject Builder Contract Agreement as its president.

The Owner filed suit against Mr. C individually, alleging that they paid more than \$1.151 million towards their new home's construction but that the project was effectively abandoned and never completed because Mr. C misappropriated the monies they paid for his personal or other use. Mr. C filed a motion to stay action and compel arbitration. In support of his motion, Mr. C relied upon the arbitration clause within the Builder Contract Agreement, which requires in part:

All controversies and claims between the Owner and Contractor directly or indirectly rising out of or relating to this Contract or this transaction will be settled by binding arbitration in the County where the property is located in accordance with Arbitration Rules of the American Arbitration Association or other Arbitrators who are mutually agreeable to the Parties.

When ruling on a motion to compel arbitration, Florida courts must consider three issues: "(1) whether a valid written agreement to arbitrate exists; (2) whether an arbitrable issue exists; and (3) whether the right to arbitration was waived."

The Builder Contract Agreement contains an arbitration provision. However, while Mr. C signed the agreement on behalf of Contractor, Mr. C was not himself a party to the contract. Under Florida law, one may not ordinarily compel arbitration "under an arbitration agreement to which he was not a party."

The contract between the parties, and specifically the arbitration provision itself, determines the issues which must be subject to arbitration. Mr. C wasn't a signatory in his individual capacity.

The Owner and Contractor. agreed to arbitrate all controversies and claims between the Owner and Contractor rising out of or relating to this Contract or this transaction." Nowhere in the agreement did the Owner consent to arbitration of any claims they may have against Mr. C individually. As a result, the Owner may not be compelled to submit their claims against Mr. C to arbitration.

Florida courts have permitted a non-party to enforce an arbitration provision against a party to the contract in two limited circumstances: "(1) when the signatory's claims allege 'substantially interdependent and concerted misconduct' by the signatory and the non-signatory or (2) when the claims relate directly to the contract and the signatory is relying on the contract to assert its claims. In this case, the matter was tried in Court.

On Tuesday, October 1, over 30 heavy equipment operators from across North Florida gathered at Ring Power's St. Augustine Demo Yard for NUCA's (National Utility Contractors Association) "Next Man Up" training event. The session aimed to enhance the skills of entry-level operators, with a strong emphasis on safety and best practices in the utility and excavation sectors.

Ring Power provided the equipment for the training, which included a 920 Wheel Loader, a 323 Excavator, and a D3 Dozer. Participants had the opportunity to operate these machines under the guidance of Ring Power Demo Operators Bryce McGuire and Mike Oster. Assisting with the event were Ring Power Sales Representatives Russ Sessions, Shaun Mitchell, Cecil Vignutti, Luke Pritchett, Jeff Osborne, James Branch, Cody Hitchcock, Brad Wiggs, and Steve Yee.

The training covered critical safety topics, such as safety and maintenance inspections, mounting and dismounting machines, machine cleanliness, working on a slope, and preventing rollovers. Bryce McGuire emphasized the importance of maintaining "three points of contact" when entering or exiting machinery. He also guided participants through the machines' safety features, warning lights, and proper use of operator manuals.

A key focus was on performing safety and maintenance inspections consistently at the start of each shift, reinforcing Ring Power's commitment to putting safety first.

#### **2021 IIJA Allocations Lagging**

Statistics released by USDOT on Sept. 18 indicate that progress on the 2021 Infrastructure Investment and Jobs Act (IIJA) is still lagging. Three years into the five-year law, just 40% of funds for highway and bridge construction have been announced or allocated. Nearly \$720 billion remains to be disbursed. The \$1.2 trillion IIJA signed into law in November 2021 included \$550 billion in new resources allocated to infrastructure projects. NUCA's advocacy efforts in the next two years are focusing on increased investment timelines for these resources in subsurface water infrastructure projects.

#### FHWA Sends \$62B In IIJA Funds To States

The Federal Highway Administration (FHWA) announced Oct. 1 it allocated \$62 billion in federal highway formula funds to states to help fund upgrades to highways, bridges, tunnels and other infrastructure around the country.

The Infrastructure Investment and Jobs Act (IIJA) NUCA strongly supported in 2021 continues to deliver resources to the construction industry. The fourth year of funding provides this \$62 billion to states and D.C. to improve highway and bridges in eligible projects. The Administration wrote in its announcement that 60,000 projects have been funded through this law, which must be reauthorized in 2026.

# SAFETY NEWS

#### Hard Hats vs Helmets

The history of hard hats is interesting. Helmets with chin straps were first used by the Roman Army in 400BC. Tribal leaders wore bronze helmets decorated with horsehair when going into battle even earlier than 400BC. The modern hard had was first used by salt mine workers in Poland in the 1500s. in 1929 E. D. Bullard patented a hard hat made from steamed canvas, leather, glue and black paint. This hard hat was inspired by the helmets worn by First World War soldiers. Construction of the Golden Gate Bridge was the first big construction project to mandate the use of hard hats. Steel was the material used for these hard hats. Later, hard hats were being manufactured using a variety of materials. Hard hats today are made from high density polyethylene or a polycarbonate resin. In 2023 OSHA announced a switch from the traditional hard hat to the safety helmet equipped with a chin strap. While it is not yet mandated, it is recommended citing improved side impact resistance and secure placement.

Workers who have become accustomed to the wearing of the current hard hat may be reluctant to use the new helmet. Change is always a challenge when implementing a new process. PPE is no different. There will naturally be those who will argue against the use of the helmet, but the issue becomes mute when the prime contractor decides to mandate the use of helmets for any construction done on their worksites. Once the helmets become the standard, workers will adapt. If you are old enough to remember the implementation of seatbelts, there was significant pushback until it became a mandate that carried penalties for nonuse. Statistics have proven that the use of seat belts save lives. It's entirely probable that the use of helmets, once established, will result in a significant improvement in head protection safety.
