The Law and Your Business

The Law and Your Business- Preliminary Injunction not available

This dispute stems from the failure to disclose unpaid sales and use taxes in the purchase and sale agreement of a restaurant. The order granting a preliminary injunction, enjoining her from alienating or transferring her real property and dissipating her assets. The contended basis for the injunction was that she intended to flee to avoid liability for any judgment.

The parties entered into a purchase and sale agreement and a bill of sale in conjunction with the acquisition. In the documents, Hamad warranted that the books and records accurately set forth all liabilities, assets, and other matters regarding the financial condition of the Business. She further promised and agreed to convey good, clear, and marketable title to all the property to be sold to be free and clear of all liens and encumbrances. Months later, it was revealed that the business was indebted to the Florida Department of Revenue for unpaid sales and use tax in the amount of \$112,621.43.

One party moved for a preliminary injunction seeking to enjoin Seller from alienating, encumbering, or transferring her real property and dissipating any of her other assets. A party seeking an injunction must demonstrate that (1) irreparable injury will result if relief is not granted; (2) there is no adequate remedy at law; (3) the party has a clear legal right to relief; and (4) entry of an injunction serves the public interest. The moving party must furnish competent, substantial evidence satisfying each prong.

Irreparable injury and no adequate remedy at law are distinct, but interrelated, prongs. What makes an injury irreparable is that no other remedy can repair it. Consistent with this concept, the movant must establish an injury that cannot be compensated by after-the-fact money damages. In the case at hand, evidence was presented that the Seller intended to dispose of her property and abscond.

The Florida courts have distinguished between the inability to obtain a judgment and the inability to collect on a judgment. The former supports injunctive relief, while the latter does not.

Although the idea that an uncollectible judgment provides an adequate remedy at law may seem a bit of a legal fiction, it is the mere availability of the judgment itself that defeats a finding of irreparable harm to warrant the issuance of a temporary injunction. A claim for money damages does not provide a sufficient basis for injunctive relief. Even where the party seeking injunctive relief alleges that the opposing party may dissipate bank assets, a judgment for money damages is adequate and injunctive relief is improper, notwithstanding the possibility that a money judgment will be uncollectible.

Industry News and Advocacy

NUCA Holds First-Ever Winter Fly-In

NUCA achieved last month an important advocacy victory across two crucial days in Washington, D.C. In the first-ever Capitol Hill event for the new NUCA Government Affairs Committee Working Group, our members met with four critical House committees, two Senate committees, nine Representatives and Senators, delivering NUCA's message of increased infrastructure resources for our important work, and offering our assistance to Congress to get the job done and sent to the President for his signature.

This event was an important milestone for the committee's Working Group, formed last year to be a quick-reaction group of NUCA members actively involved in our government advocacy program. The Feb. 25-26 "NUCA Winter Fly-in" featured 20 NUCA members and supporting National staff, traveling to Capitol Hill to achieve this year's opening advocacy goal: explaining first-hand to the nation's new decision makers the incredible value our industry delivers every day to tens of millions of American citizens.

NUCA Chairman Testifies At U.S. House Water Infrastructure Hearing

This hearing, held March 11 by the U.S. House of Representative's Committee on Transportation and Infrastructure subcommittee on Water Resources and Environment, featured NUCA's past chairman and three other expert witnesses discussing the status of EPA's water infrastructure resources. NUCA's former Chairman Dan Buckley of member company Garney Construction hammered home in his powerfully delivered testimony several key takeaways of our industry and the importance of the Clean Water State Revolving Fund (SRF) and the Drinking Water SRF.

Buckley explained that the SRF system has faced persistent challenges that undermine its ability to meet the nation's growing needs. The resources allocated to the SRF by Congress have never fully matched the scope of the problem. Our advocacy on Capitol Hill in February directly led to NUCA's and Chairman Buckley's expert testimony at this hearing. The March 11 subcommittee hearing is online and can be viewed via the Committee's website at transportation.house.gov.

Trump Tariffs: NUCA Responds

NUCA is urging the Trump Administration to reconsider its tariffs on steel, aluminum, and other construction materials. President Trump announced in his March 4 address to Congress that his tariffs on foreign-made steel and aluminum would go forward. In his media statement, NUCA Chief Executive Office Doug Carlson responded, "While NUCA strongly supports efforts to increase the domestic manufacturing of the robust products we use to build America's clean water infrastructure, an increase of 25 percent on these foundational materials will raise project costs, delay project completion, and further strain the American taxpayer who finances these community improvements." NUCA encourages the Administration to consider exemptions for critical materials used in domestic infrastructure projects. We will keep the NUCA membership informed about the Administration's next steps.

Administration Repeals Existing NEPA Regs

On Feb. 18 the Trump administration issued an interim final rule repealing decades of National Environmental Policy Act (NEPA) regulations, marking a significant shift in federal environmental policy. Signed into law in 1970, NEPA required agencies to assess the environmental impacts of major federal projects, a process often criticized for causing delays in infrastructure development. The White House, under Trump's direction, rescinded all Council on Environmental Quality (CEQ) regulations dating back to 1977, following his Jan. 29 executive order titled "Unleashing American Energy" (EO 14154).

This interim final rule aims to streamline permitting for energy and infrastructure projects like pipelines and highways. Legal challenges under the Administrative Procedure Act are expected, though the D.C. Circuit's recent ruling against CEQ authority may bolster Trump's position. A working group is being established to assist federal agencies in revising their own NEPA rules. Agencies will remain responsible for conducting environmental reviews — and NEPA remains the law of the land — but enforceability will shift from CEQ's overarching rules to these agency-specific regulations.

Did you know there is a Heat Awareness Day?

Heat awareness day is always **the last Friday in May**. We are coming off our seasonal cold spell where we had to put on extra clothing to protect ourselves from the cold. Now, we are approaching summer and the heat that our area is famous for. We know it's going to be hot. It's been that way for centuries and we should be prepared for it but many times we end up putting out fires because we haven't laid the groundwork for working safety in the heat. Florida ranks 4th in total deaths related to heat behind, Arizona, Texas and Nevada. In 2024 there were 19 worker deaths related to heat in Florida. The preventive actions we need to take are simple.

- Provide workers with water and an opportunity for shade.
- Take frequent breaks until the worker acclimates and build tolerance to the heat.
- Plan for emergencies and know how to recognize heat related incidents.
- Monitor our workers for signs of illness.

The nature of our work is to be exposed to the elements. That includes heat.

- Work in direct sunlight – adds up to 15 degrees to the heat index.
- We perform prolonged strenuous work.

HEAT INDEX	RISK LEVEL	PROTECTIVE MEASURES
< 91°F	Lower (Caution)	Basic heat safety and planning
91°F to 103°F	Moderate	Implement precautions and heighten awareness
103°F to 115°F	High	Additional precautions to protect workers
> 115°F	Very High to Extreme	Triggers even more aggressive protective measures

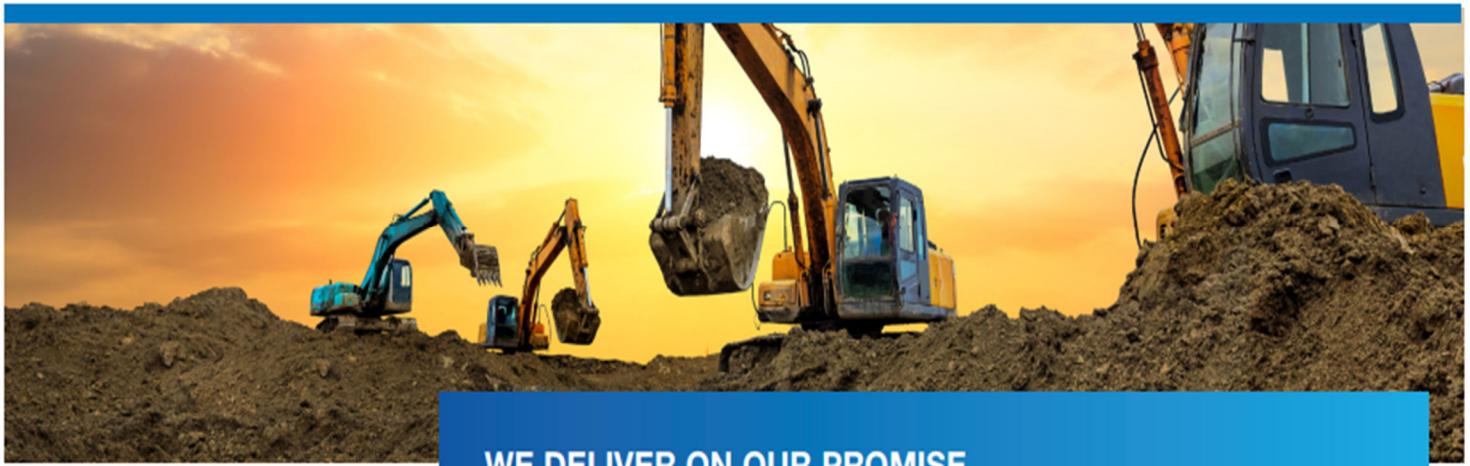
