# The Law and Your Business

## The Law and Your Business- Venue Clause in Contract Tony Zebouni, Lindell & Zebouni, P.A.

In a recent case involving where a lawsuit will be heard, The venue selection clause and the choice of law clause read as follows: “The Subcontractor acknowledges and agrees that any controversy or claim arising out of or relating to this Contract, or the breach thereof, shall be settled under the laws of the State of Florida with venue in Lee County, FL.”

In Florida, contracting parties are permitted to agree that any litigation stemming from their contract must be heard in a specific forum. The most important consideration for the court in the construction of a written contract is the intent of the parties, and where the language used is clear and unambiguous the parties' intent must be garnered from that language.

A crucial question in interpreting a forum selection clause is whether the clause is permissive or mandatory. “Permissive forum selection clauses constitute nothing more than a consent to jurisdiction and venue in the named forum and do not exclude jurisdiction or venue in another forum.” By contrast, mandatory forum selection clauses provide “for a mandatory and exclusive place for future litigation.”

Importantly, if the forum selection clause states or clearly indicates that any litigation must or **shall** be initiated in a specified forum, then it is mandatory.

When parties designate a specific county in Florida by name, using words of exclusivity like “agree” and “shall,” they intend to mandate that venue.

This clause is distinguishable from those we have held to be permissive. (holding permissive a clause stating “any litigation concerning this contract shall be governed by the law of the State of Florida, with proper venue in Palm Beach County”). While this clause appears at first glance to be similar, it has key differences. a mandatory language “shall” only apply to the choice of Florida law rather than to the venue selection, which is set off by a comma and cannot be modified grammatically by the language “shall be governed by.

While the language may be clear and unambiguous, in construction contracts Florida Statute 47.025 governs and trumps any contract language that would move venue outside the state of Florida on Florida projects.

## Industry News and Advocacy

### **Trump White House Zeros Out SRFs In 2026 Budget**

Expecting controversy, late Friday, May 2, the Trump Administration released its proposed FY2026 budget for the U.S. government. The proposal calls to cut both of the industry-critical Drinking Water and Clean Water State Revolving Funds by over 80%, with the proposal inaccurately claiming that the states could finance these projects and did not need federal government help.

NUCA immediately released a strong statement, pointing out that SRF funding is already inadequate and that states "simply will not be able to fill the funding gap." While Congress is ultimately responsible for passing a federal budget, the White House proposed cuts are another example of our industry being used as a political football at the expense of the nation's health and economy. Our 2025 Washington Summit was perfectly timed to remind our lawmakers that local water infrastructure is critical national infrastructure.

### **ASCE Report Card On Water Infrastructure: Needs Improvement**

The American Society for Civil Engineers (ASCE) released in April their quadrennial [report card on America's infrastructure](#), giving the nation an improved grade of C, up from 2021's C-. However, drinking water's dismal grade of C- has not improved since the last report card, nor has wastewater's unchanged grade of D+ and stormwater's D. ASCE's report card remains a very timely reminder to policymakers and the American voter that the only way to build a better America is to deliver more resources for its construction.

### **Independent Contractor Standard Will Not Be Enforced, Says USDOL**

The U.S. Labor Department's Wage and Hour Division issued a memo to staff May 1 telling them not to enforce the Biden administration's independent contractor standard, and reverted enforcement resources back to the 2019 guidelines issued by the first Trump Administration. While the Biden era rule remains in effect, the change is specific to the department's enforcement priorities. The Trump USDOL said it is taking another look at the regulation but has not yet started the process to rescind it.

##### **Cost of Utility Strikes**

Utility strikes are among the most costly and dangerous incidents in underground construction, leading to financial losses, delays, fines, and serious injuries. With over 500,000 annual strikes in the U.S. costing society \$30B, key causes include outdated maps, inaccurate locates, and neglecting 811 guidelines.

##### **Good News – Prevention is Possible**

Utility strikes are largely preventable with the right strategies and technologies. Here are some best practices to mitigate risks:

1. Subsurface Utility Engineering (SUE): Investing in SUE ensures a comprehensive understanding of underground utilities before breaking ground.
2. Advanced Technology: Tools like ground-penetrating radar (GPR) and real-time utility detection systems, such as Live Dig Radar (LDR), provide accurate, real-time data to avoid strikes.
3. 811 Call Before You Dig: Despite being federally mandated, nearly 25% of utility strikes occur due to failure to notify 811. Adhering to this step is crucial.
4. Vacuum Excavation: This non-destructive digging method minimizes the risk of damaging utilities.
5. Training and Awareness: Regular training sessions for workers on safe excavation practices and emergency response procedures can significantly reduce incidents.

##### **From an Insurance Perspective**

For underwriters, a history of utility strikes is a red flag. Companies that demonstrate proactive risk management—through advanced technology, meticulous site preparation, and adherence to safety protocols—are better positioned to negotiate favorable policy terms and maintain competitive premiums.
